# 1 Description

The handset TOUCHdown is part of LOGICDATAs system for electrically height-adjustable desks. TOUCHdown is characterized by its modern design and the easy installation – no milling necessary. Easy mounting with just a few screws. The push-push feature allows to retract the handset under the tabletop. The large keypad turns the intuitive handling into a convenient pleasure. Save up to four memory positions. At the push of a button the table will drive to the saved position. You can switch the height indication from cm to inch and vice-versa. The handset can be customized to meet individual requirements.






Figure 1: Dimensions. Tolerances according to DIN ISO 2768-1.

# 5 Safety

### **Electrical hazard**

When the handset is connected to the power supply, electrical power is applied to the connectors and the inner parts of the handset. Contact with live components can cause severe injury.
